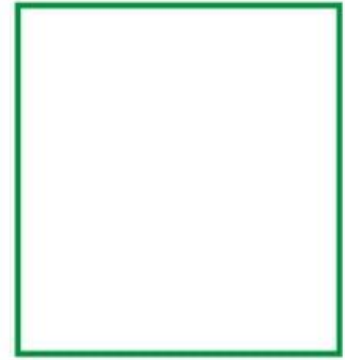

### TERMS AND CONDITIONS

1. That this investment scheme shall be for **COCONUT PLANTATION SCHEME** only for a period of Twenty (20) Calendar years beginning from the date of execution of this.
2. That the **INVESTOR(s)** herein has agreed to invest into the **COCONUT PLANTATION SCHEME** of the Company and thus hereby invest(s) the sum of **One Million and Ffty Thousand Naira (N1,050,000.00)** only.
3. That the first **COCONUT HARVEST time** under this Agreement shall be after Four (4) Calendar years of this investment and that the subsequent **COCONUT HARVEST** shall be yearly/Annually according to the time and season of coconut harvest.
4. That in the case of the **FIRST HARVEST RETURNS**, the **INVESTOR(s)** herein shall be entitled to **50% HARVEST RETURNS (HR)** after Four Calendar years after deductions of the running costs and maintenance.
